No. GH/TD/04/AJP/102018/419/CH:- In exercise of the powers conferred by sub-section (1) of section 6 of the Gujarat Scheduled Castes, Scheduled Tribes and Other Backward Classes (Regulation of Issuance and Verification of Caste Certificates) Act, 2018 (Guj. 19 of 2018), the Government of Gujarat hereby constitutes the following Scrutiny Committees for the purpose of verification of Caste Certificates issued by the Competent Authority under sub-section (1) of section 4 of the aforesaid Act.

1. State Level Scrutiny Committee for supervision, monitoring and to direct all the Divisional Scrutiny Committee's shall be consisting of the following members, namely:-
 - (a) Deputy/Joint/Additional Secretary of the Tribal Development Department;
 - (b) Commissioner, Tribal Development;
 - (c) Research Officer, Tribal Research and Training Institute;
 - (d) Section Officer (Caste Certificate), Tribal Development Department
 - (e) Deputy Commissioner shall be the Member Secretary of the State Level Scrutiny Committee.

Note: The senior most member amongst above (a) and (b) shall be the Chairman of the Committee.

2. (A) Divisional Scrutiny Committees shall be consisting of the following Members, namely:-
 - (a) Joint Commissioner, Commissionerate of Tribal Development/Resident Additional Collector who shall be the Chairman of the Committee;
 - (b) Assistant Commissioner, Commissionerate of Tribal Development;
 - (c) Research Officer, Tribal Research and Training Institute having intimate knowledge in identifying the tribes, tribal communities, parts of or groups of tribes or tribal communities;
 - (d) Tribal Development Officer;

- (e) Assistant Tribal Development Officer shall be the Member Secretary of the Divisional Scrutiny Committee.
- (B) (i) Divisional Scrutiny Committee, Gandhinagar 01 shall have jurisdiction for Banaskantha, Sabarkantha, Aravalli, Gandhinagar, Ahmedabad, Bhavnagar, Botad, Mehsana, Patan districts;
- (ii) Divisional Scrutiny Committee, Gandhinagar 02 shall have jurisdiction for Surendranagar, Rajkot, Morbi, Kutch, Jamnagar, Devbhumi dvarka, Junagadh, Gir-Somnath, Porbandar, Amreli districts;
- (iii) Divisional Scrutiny Committee, Vadodara shall have jurisdiction for Vadodara, Chhotaudepur, Anand, Kheda, Panchmahals, Dahod, Mahisagar districts;
- (iv) Divisional Scrutiny Committee, Surat shall have jurisdiction for Surat, Tapi, Dangs, Navsari, Valsad, Bharuch and Narmada districts.
