# **NOTIFICATION** Tribal Development Department, Sachivalaya, Gandhinagar. Dated the 20<sup>th</sup> October, 2015

CONSTITUTION No.MKM-202014-111-G :- In exercise of the powers conferred by the proviso OF INDIA. to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Principal, Class II in the Government Ideal Residential School for Scheduled Tribes in the General State Service under the Commissionerate of Tribal Development, Gujarat State, namely :-

- These rules may be called the Principal, Class II, Recruitment Rules, 2015.
- Appointment to the post of Principal, Class II in the Government Ideal Residential School for Scheduled Tribes in the General State Service under the Commissionerate of Tribal Development Gujarat State, shall be made either :-
  - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who;
    - (i) have worked for not less than seven years in the cadre of Assistant Teacher, Class III, in the secondary section and / or higher secondary section in the Government Ideal Residential School for Scheduled Tribes under the Commissionerate of Tribal Development Gujarat State, and
    - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill in the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who

possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

### (b) by direct selection

- 3. (a) The appointment by direct selection and by promotion shall be made in the ratio of 1:2.
  - (b) The appointment by promotion from the cadre of Assistant Teacher, Class III, in the secondary section and Assistant Teacher, Class III, in the higher secondary section shall be made in the ratio of 2:1.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall
  - (a) not be more than 39 years of age:--

Provided that the age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

#### (b) possess -

(i)

a postgraduate degree in any discipline with atleast 55 percent marks or its equivalent grade B in the seven point scale with letter grades O, A, B, C, D, E and F obtained from any of the Universities established or incorporated by or under the Central or a State Act in India, or any other educational institution recognised by the Government as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and

(ii)

a bachelor degree in education with atleast 60 percent marks or its equivalent grade B in the seven point scale with letter grades O, A, B, C, D, E and F obtained from any of the Universities established or incorporated by or under the Central or a State Act in India, or any other educational institution recognised by the Government as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956;

Explanation

Where the University or College or Institution declares results in

grade point, which is on a scale of seven point, the following mechanism shall be referred to ascertain equivalent marks in percentage:-

- the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
- (c) have about five years' combined or separate experience of teaching or inspecting educational institutions or administration in educational institutions recognised by the Government after obtaining the academic qualification specified in clause (ii) of sub clause (b) above.
- (d) possess adequate knowledge of Gujarati or Hindi or both.
- 5. The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 7. The candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and to pass the post training examination in accordance with the provisions of the Gazetted Officer's (Pre-service Training and Examination) Rules, 1970.
- 8. The candidate appointed by direct selection shall have to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
- 9. The candidate appointed either by direct selection or by promotion

shall have to undergo such training and pass such examination as may be prescribed by the Government.

10. The candidate appointed by direct selection shall have to furnish a security and surety bond in such forms, for such amount and for such period as may be prescribed by the Government.

- (i) for the figures and word "39 years", the figures and word "44 years" strall be substituted:
- (ii) after the existing proviso, the following proviso shall be inserted, namely:-

"Provided further that nothing contained in clause (b) of subrule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned."
