No.MKM-202014-116-G:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Assistant Teacher, class-III (other than Assistant Teacher for Special or Technical or both subjects). in Secondary Section of the Government Ideal Residential School for Scheduled Tribes in the subordinate service of the Commissionerate of Tribal Development, namely;

1. These rules may be called the Assistant Teacher, class-III (other than Assistant Teacher for Special or Technical or both subjects), in Secondary Section of the Government Ideal Residential Schools for Scheduled Tribes in the subordinate service of the Commissionerate of Tribal Development Recruitment Rules, 2014.

Appointment to the post of Assistant Teacher, class-III (other than Assistant Teacher for Special or Technical or both subjects) in Secondary Section of the Government Ideal Residential School for Scheduled Tribes in the subordinate service of the Commissionerate of Tribal Development shall be made either,

by temporary transfer on deputation basis from amongst the persons working on the cadre of Teacher (other than Assistant Teacher for Special or Technical or both subjects) of the Government Secondary Schools or Schools under Education Department and who passess the educational qualifications as prescribed in clause, (i) and (ii) of sub rule (b) of rule 3 for direct selection; or

To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,

(a) not be more than 32 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess -
- a Bachelor's degree in Arts, Science or Commerce obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed as University-under section 3 of the University Grants Commission* Act 1956; and

- a Bachelor's degree in Education obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956,
- have passed "Teachers Aptitude Test (TAT)" conducted by the Gujarat Secondary and Higher Secondary Education Board, Gandhinagar with at least 50 % per cent marks: Provided that the marks secured by the candidate in Teachers Aptitude Test shall be valid for five years from the date of the result of the said Test;

possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(e) possess adequate knowledge of Gujarati or Hindi or both.

The selection of a candidate shall be made on the basis of a selection list which shall be prepared on the basis of marks secured by the candidates in Teachers Aptitude Test and other educational qualifications prescribed in clauses (i) and (ii) of sub rule (b) of rule 3 for direct selection. Teachers Aptitude Test shall be given a weightage of 70 per cent and 30 per cent weightage shall be given to the other prescribed educational qualifications as mentioned below:

- 9. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such forms, for such amount and for such period as may be prescribed by the Government.
