No. GTD/04/2025/TDD/PUR/e-file/25/2023/0346/KH: In exercise of the powers conferred by the proviso to article: 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Assistant Tribal Development Officer, Class III (Pre-service Training and passing of Post-training Examination Rules, 2019, namely:

1. (1) These rules may be called the Assistant Tribal Development Officer, Class III (Pre-service Training and passing of Post-training Examination) (Amendment) Rules, 2025.
(2) They shall come into force from the date of their publication in the Official Gazette.


2. In the Assistant Tribal Development Officer, Class III (Pre-service Training and passing of Post-training Examination) Rules, 2019, in rule 9,

(i) in sub-rule (2), for the words, "sixty percentage", the words, "fifty per cent" shall be substituted;

(ii) after sub-rule (2), the following sub-rule shall be added, namely:-

"(3) In case a candidate is not able to obtain the qualifying standard in only one question paper in the examination, such candidate shall be given grace marks up to 5% of the total marks for that question paper and thereafter, if he obtains the marks equal or more than qualifying standard, he shall be declared as passed"
